

**Authorisation to collect Central Excise and Service Tax
through e- Payment**

It has been decided in consultation with Central Board of Excise and Customs to authorise your bank to collect Central Excise Duties and ServiceTax through e-payment as per the following interim accounting arrangement prescribed by them:

(a) your bank may accept e-payments for all Central Excise and Service Tax Commissionerates without the restriction of Commissionerate-wise authorization.

(b) as regards physical collection of CBEC revenue the existing commissionerate-wise restriction would continue.

(c) for all authorised commissionerates, your bank will collect only physical payments through "existing Focal Point Branches."

(d) collection through e-payment for all Central Excise and Service Tax Commissionerates will be made at a branch in Chennai for Central Excise Duties and at Mumbai for Service Tax at such CBS branches (identified by you bank) for scrolling.
