Sub: Indirect Tax Dispute Resolution Scheme 2016- reg.

Attention of all Trade & Industry is invited to the Notification No. 29/2016-CE(NT) dated 31st May, 2016 issued under F.No. 1080/06/DLA/IDRS/2016 by CBEC, New Delhi.

- 2. The Chapter XI of the Finance Act, 2016 (28 of 2016) comprising of Section 212 to 218, is in respect of the **Indirect Tax Dispute Resolution Scheme, 2016**. The said scheme allows the party in appeal before the Commissioner (Appeals) on 1st March, 2016, to file a declaration before the Designated Authority for the purpose of availing the benefit of this scheme.
- 3. As per clause (e) of sub-section (1) of section 213 of the Finance Act, 2016, Shri Ubaidullah Khan, Assistant Commissioner, Central Excise, Customs & Service Tax, Aurangabad has been authorized to function as 'Designated Authority' for the purpose of the Indirect Tax Dispute Resolution Scheme 2016 in the jurisdiction of Aurangabad Commissionerate.
- 4. The Indirect Tax Dispute Resolution Scheme Rules, 2016 has been notified by Notification No. 29/2016-CE(NT) dated 31st May, 2016. These rules provide for the forms to be used for making the scheme operational.
- 5. All the Trade Associations & Chambers of Commerce and members of the Regional Advisory Committee/Public Grievance Committee are requested to publicize this scheme amongst their member constituents.
