Sub.: Jurisdiction of Commissioner of Central Excise(Audit) and Commissioner of Central Excise(Appeals) effective from 15.10.2014-reg.

In exercise of powers delegated by the Central Board of Excise and Customs vide notification no. 29/2014-Central Excise, (N.T.) dated 16<sup>th</sup> September, 2014 the jurisdictions of Commissioner of Central Excise (Audit) and that of Commissioner of Central Excise (Appeals) in Nagpur Zone are hereby specified under rule 3 of the Central Excise rules, 2002.

- 2.
