**Trade Facilitation Notice No. 01 / 2019-20**  
**dated 30.08.2019**

The Government of India has introduced **Sabka Vishwas (Legacy Dispute Resolution) Scheme, 2019** as a onetime measure for full and final settlement of pending disputes relating to Central Excise and Service Tax with an objective to liquidate the pending arrears, conclusion of pending enquiry & investigation, voluntary disclosures of unpaid duties / taxes etc.

2. The **Sabka Vishwas (Legacy Dispute Resolution) Scheme, 2019** has been notified by the Government vide Notification No.5/2019-CE(NT) dated 21.08.2019 and issued Board's Circular No. 1071/4/2019/CX-8-Pt.III dated 27.08.2019 (copy enclosed). The scheme has been made effective for the period from 01.09.2019 to 31.12.2019. The beneficial scheme exclusively applies to legacy matters pertaining to Central Excise & Service Tax.
3. All the members of Trade and Industry are requested to avail the opportunity of maximum use of above scheme and take benefits as provided under the scheme and make the scheme a grand success.
4. The Department is looking forward towards overwhelming positive responses from the Trade & Industry for availment of above beneficial scheme.
5. The Trade and Industry is requested to bring the contents of this Trade Facilitation Notice to their members and public in general.
