The Budget for the year 2011-12 is likely to be presented by the Hon'ble Finance Minister on 28th February, 2011 at 11.00 a.m. It may kindly be noted that all the budget documents including Customs, Central Excise and Service Tax notifications, Finance Bill, Budget Synopsis, Explanatory Memorandum etc. will be posted on the web sites namely, www.cbec.gov.in, www.indiabudget.nic.in, www.finmin.nic.in, immediately after the conclusion of the Budget Speech of the Finance Minister.

2. These budget documents will also be electronically transmitted to all Customs/ Central Excise/ Service Tax Zones through NICNET. Accordingly it is requested that necessary arrangements may be made to ensure that the e-mail system in your Zone is fully functional.
3. However, unlike the previous budgets, we shall not be supplying budget CDs containing various budget documents, as NIC has discontinued making these CDs. However, as stated above, all the budget documents will be made available through the above named websites. As such, it is requested that internet connection must be made available to the field formations in your zone.
4. Further the practice of the distribution of hard copies of the budget documents to field formations except Delhi and NCR through the Directorate General of Inspection is being discontinued from this Budget.
